Please be sure to read all rules. In addition to the following rules, all ABGA Sanctioned show rules will apply. **By entering the show, exhibitors and parents/guardians are agreeing to abide by all rules.** It also gives permission for pictures/videos being taken during the show and used for advertising purposes.

**Entries and payment: NO REFUNDS.** Entries and payment must be **completed ONLINE** at <https://showman.app/shows#/wv-boer-goat-blitz>. Entry fees are per animal. **Early rate by May 10, 2019:** Market goat \$25, Market Lamb \$25, ABGA \$25 per show or all 3 for \$50. **Late rate May 11-May 15, 2019:** Market goat \$40, Market Lamb \$40, ABGA \$40 per show or all 3 for \$100. **Entry after May 15 will be CASH only**, no checks or credit. Show day entries will be accepted for the late fee. **May 18, 2019** will be used to determine ABGA classes for both days. **Late entries are not guaranteed pens.**

**Arrival and Check-in:** Gates open at **10 am Friday**. **All animals will enter through side gate #3**---not the main gate. Check-in will be open **Friday 10 am – 4:00 pm, Saturday 6:00 – 8:00 am**. All market animals must be weighed by **5:00 pm Friday**.

**Pens:** No pen fee for animals. Pen size is 4 x 5. **Tack pens are \$5.00.** Pens will be designated when you arrive. No set-up until Friday at 10 am. **Late entries are not guaranteed pens.**

**Shavings:** Shavings are offered for **\$6.00** per bag and must be reserved with early entries. Additional quantities will not be available.

**Youth Market Additional Rules:** GOATS show first, then LAMBS. ***Show open to any youth under 21 years of age as of January 1, 2019.***

All market entries will show together regardless of sex. Does will be allowed to be shown in market goat but may not be shown in ABGA shows on May 18-19. Weigh-in is scheduled **until 5 pm Friday**. All animals will be weighed and divided by weight into classes. No reweighs.

**Market Showmanship:** Age division will be determined based on age as of January 1<sup>st</sup>. Junior Division- under 9 years of age, Intermediate Division- 9-13 years of age, Senior Division- 14-20 years of age. Exhibitors must have paid entry fee for the market show.

**Health Requirements:** Animal Health checks will be done before entering the barn area. All out-of-state sheep and goats must be accompanied by an Official Interstate CVI dated within 30 days. WV breeding goats must have an Official CVI dated within 30 days or a West Virginia Honor Herd Certificate. No refunds given for animals required to leave the fairgrounds.

**Miscellaneous:** Exhibitors are responsible for safety and care of their goats. Exhibitors and their families release the Jefferson County Fair Association, WV Boer Goat Blitz and any committee members from all responsibility for loss or damages or accidents.

No animals can run free on the fairgrounds; dogs will not be allowed in the barn or arena area. **No Smoking within 20 feet of the barns or show arena. NO ALCOHOL ALLOWED ON FAIRGROUNDS. No unethical treatment of animals will be allowed.**

**In case of a discrepancy, or for rules not adequately covered, show committee decision will be final.**
